The following complaints of misconduct are laid by the Bar Council against Wong Kwai Sang before the Barristers Disciplinary Tribunal:-

PARTICULARS OF MISCONDUCT

COMPLAINT 1

Engaging in a course of conduct which might bring the profession of barrister into disrepute and/or was prejudicial to the administration of justice, contrary to paragraphs 6(b) of the Code of Conduct of the Bar of the Hong Kong Special Administrative Region then in force.

PARTICULARS

- 1.1 Wong Kwai Sang, on or about 13 October 2009:-
 - 1.1.1 you used a purported will of Mr Au She-cham dated 16 June 2009, which was and which you knew or believed to be false, with the intention of inducing an officer of the High Court, to accept it as genuine, as evidenced by your

conviction in DCCC 158/2013 of the offence of using a false instrument contrary to section 73 of the Crimes Ordinance (Cap 200);

- 1.1.2 you, being required by law to make a statement on oath and being lawfully sworn, wilfully made a false statement by way of affirmation before a Commissioner for Oaths, namely that the said Mr Au She-cham had made and executed his last will dated 16 June 2009 and appointed you to be the sole executor, for the purpose of an application for probate thereof, which was material for that purpose and which you knew to be false or did not believe to be true, as evidenced by your conviction in DCCC 158/2013 of the offence of making a false statement on oath contrary to section 32 of the Crimes Ordinance (Cap 200).
- 1.2 Wong Kwai Sang, on or about 25 November 2009, used a copy of the purported will referred to in paragraph 1.1.1 above, which was and which you knew or believed to be false, with the intention of inducing a police officer to accept it as copy of a genuine instrument, as evidenced by your conviction in DCCC 158/2013 of the offence of using a copy of a false instrument contrary to section 74 of the Crimes Ordinance (Cap 200).

COMPLAINT 2

Engaging in a course of conduct which was dishonest, contrary to paragraph 6(b) of the Code of Conduct of the Bar of the Hong Kong Special Administrative Region then in force.

PARTICULARS

Wong Kwai Sang, between 7 January 2010 and 4 March 2010, you stole a total sum of HK\$15,400, the property belonging to Mr Cheung Wai-ming, as evidenced by your conviction in DCCC 158/2013 of 6 counts of theft contrary to section 9 of the Theft Ordinance (Cap 210).
