HKBA's Statement in Response to Proposed Use of the CGO as Headquarters of the DOJ with space for law-related NGOs

The Hong Kong Bar Association welcomes the proposal to allocate the West Wing of the Central Government Offices for the use of the Department of Justice and law-related non-governmental organizations.

The centralization of the various internal divisions of the Department of Justice will likely improve intra-and inter-departmental communication, and will no doubt facilitate the efficiency of the Department's service to the government and to the community as a whole.

Further, the provision of space in the Central Government Offices for law-related non-governmental organizations, including organizations to promote arbitration and mediation services, is particularly welcome. The Bar Association is pleased to see the commitment on the part of the Hong Kong SAR Government in taking an active role in fostering the development of international arbitration as part of the mainstream legal services to be provided by Hong Kong legal professionals. We believe that the reservation of premises for housing law-related non-governmental organizations will enhance the resources for training, accreditation, and general collaboration between these organizations and the administration, and will serve to improve the quality and accessibility of legal-related services to the community in the years to come.
