## Report of the Special Committee on Constitutional Affairs and Human Rights 2014

Members of the Special Committee on Constitutional Affairs and Human Rights have assisted in last 12 months in the drafting of the following press releases, submissions and position papers of the Bar Association:

They include assisting the Bar Council in responding to important public events in Hong Kong or concerning Hong Kong from the legal perspective, assisting the Bar Council in making submissions responding to consultations on matters with a constitutional law and/or human rights dimension, monitoring for the Bar Association as a stakeholder of the unified screening mechanism for the assessment of non-refoulement claims, and assisting the Bar Council in making reports to the United Nations treaty bodies on the compliance of international human rights guarantees in Hong Kong.

Additionally, from time to time, the Special Committee handles invitations and queries from organizations in Hong Kong and abroad for information and comments on public law and human rights matters. The Special Committee also sends a member to represent the Bar Association in the Administration's Human Rights Forum.

The past year has been a demanding one on members of the Special Committee. Many of the items of work had to be finished for public release both within a rather short time frame and following decisive balancing and judgment. The Chairman takes this opportunity to thank all members for their contributions. Special mention goes to Earl Deng, who accepted the invitation of the Bar Association to go in May 2014 from London (where he was placed at the time) to Geneva to attend the hearing of the United Nations Committee on Economic, Social and Cultural Rights discussing the periodic report of the HKSAR.
