Report of the Special Committee on Discipline

Investigation

1. During 2011 (as of 28 November 2011), there have been **14 disciplinary matters** (13 were formal complaints and 1 was an enquiry made by 8 members in respect of possible breaches of the Bar Code). In 2010, there were 26 formal complaints. The result/progress of the 14 cases are as follows:

Barristers Disciplinary Tribunal

3. During the year, the Barristers Disciplinary Tribunal (BDT) handled a total of **5 BDT** matters, 3 of these were concluded and the findings of the BDT are as follows:-

- 4. A halted BDT referral arisen from a complaint in 2003 was resumed this year upon the completion of related court proceedings.
- 5. In total, at present, there are **4 outstanding BDT matters**, 2 of which (from complaints in 2008) are being handled by the BDT, whilst the other 2 (1 from a complaint in 2003 and 1 from 2010) are pending referral to the BDT.
- 6. In CACV 102/2010, Mr Mui Kwok Keung Louie lodged an appeal against the findings of the BDT set out in its Statement of Findings dated 8 April 2010. The Court of Appeal (Hon Yuen & Fok, JJA and Hon. To J) dismissed Mr Mui's appeal on 21 March 2011.
- 7. These people contribute a significant amount of their time investigating and advising on discipline matters, and without their help the Bar could not be self-regulating in discipline matters. I am grateful for all their help.
