## Special Committee on Discipline Annual Report 2014

## Investigation

1. During 2014 (as of 31 December 2014), there have been **10 disciplinary matters** (7 were formal complaints and 3 were initiated by the Bar Council itself). In 2013, there were 8 formal complaints. The results/progress of the 10 cases are as follows:

2. Also during this year, 5 disciplinary matters arising in 2012 (all were formal complaints) and 4 disciplinary matters arising from 2013 (1 was formal complaint and 3 were initiated by the Bar Council itself) were investigated. The results/progress of these 9 cases are as follows:

3. At the beginning of the year the Committee enquired with 21 practicing members (16 of them renewed their Practising Certificates late while the remaining 5 members neither renewed their Practising Certificates nor gave notifications of cessation of practice at the end of 2013) as to their positions of practice from 1 January 2014 up to the date of renewal/the date of enquiry. As a result of the enquiries, one member who

was practicing without holding a valid Practising Certificate, 3 members who had renewed their Practising Certificates late once or more times in the last five years, and 1 member who did not give notification of his change of status from a practicing barrister to an employed barrister forthwith and continued to maintain a set of professional chambers after ceasing to be a practicing barrister, which were only revealed upon the Committee's enquiry into the status of his practice, were admonished by the Chairman of the Bar Council.

## **Barristers Disciplinary Tribunal**

4. During the year, the Barristers Disciplinary Tribunal (BDT) handled a total of **9 BDT** matters, 7 of which were concluded and the findings of the BDT are as follows:-

- 5. One Respondent in a BDT case (Case Ref: 24/2010(2)) which concluded this year, has lodged an appeal against both the findings and sanctions made by the BDT to the Court of Appeal.
- 6. In January 2014, the Bar Council discontinued referral of a matter arising from a complaint made in 2012 to the BDT upon taking independent legal advice.
- 7. At present, there are **5 outstanding BDT matters**, 2 of which (1 from a complaint in 2008 and 1 from 2014) are being handled by the BDT, whilst the other 3 (1 from a complaint in 2003, 1 from 2012 and 1 from 2014) are pending referral to the BDT.

8. These people contribute a significant amount of their time investigating and advising on discipline matters, and without their help the Bar could not be self-regulating in discipline matters. I am grateful for all their help.
