PATRICK YU MEMORIAL SCHOLARSHIP APPLICATION FORM

Please refer to the Patrick Yu Memorial Scholarship Rules (“the Rules”) before filling out this form.

The object of the Scholarship is to encourage candidates of high calibre, who have been qualified to practise as a barrister in Hong Kong for a period of 5 years or less, to practise in criminal work or to join criminal practice.

Under clause 5 of the Rules, any person who can satisfy the following criteria is eligible to apply and be awarded the Scholarship: (a) has been qualified to practise as a barrister in Hong Kong for a period of 5 years or less; (b) is holding a practising certificate issued by the Bar Association; (c) is a permanent resident of the Hong Kong Special Administrative Region; (d) is interested and has aspiration to practise in criminal work or to join criminal practice in Hong Kong, and (e) has submitted an application for the Scholarship, and attended an interview as required under Rule 13.
